
Fiji Nurses Specialization Framework(ICN criteria) – Pillars of nursing specialization.

- Population Health Needs-The health needs of the population must always be at the forefront and center of any changes to clinical practice and professional career pathways.
- **System strengthening-** Graduate profile of PGD programmes developed strongly emphasizes on patient safety and the delivery of high-quality care through commitment to improving clinical governance, developing practice, mentoring and developing other healthcare staff (Graduate profile).
- Regulation- PGD programmes developed adhere to Domains and standards of Fiji Nursing Council and secure FNC certificate of recognition for registration of programme with FHEC.
- Affiliation PGD programme development has enabled SoN to establish professional affiliations like working in partnership with NCCTRC with Emergency Nursing programme, Midwifery programme with Burnett Institute in 2022 and UNFPA, MoUs with PIHOA-RMI, Cook Islands.

- Recruitment of Lecturers, Assistant/Associate Professors, Professors for specialized Clinical programmes and level 9 studies- sustainability of the programs- WHO CC, National Critical Care and Trauma Response Centre(NCCTRC), UTS, UNFPA.
- Recognition -As a cadre of nurses with specialized knowledge and skills in this field of nursing practice.
- Work in progress with FNC to establish scope of practice/Job description for the PGD programs.
- Seeking external accreditation for maintaining standards.

#### Achievements

- Graduates are contributing positively and making impact to Health Care Service delivery... No study to validate but based on reports received..
- PGD programs have revamped/revitalized research portfolio for SoN for first time SoN had 5 oral presentations, 3 poster presentations in 2023 PIHRS.
